

Feldenkrais Research Journal Reference Style Guide

General Notes

- All References to be listed at the end of your article.
- All References in the final list must appear within your article text, or footnote.
- All citations in your article must appear in your References list.
- References are in alphabetical order, by first author, then second author, third author, etc.
- Authors with more than one listing, put in reverse chronological order, that is, most recent date appears first.
- If there are two entries with the same date, label them a, b, e.g. 1999a, 1999b. Ensure this full date listing also appears in your citation in-text.
- Default – no period at end of reference entry. Put period at end of Reference ONLY where there is a following weblink etc (for clarity of separation). NO full stop/period at end of weblink

ARTICLES		Note Journal Title (only) is <i>italicised</i> . Please include DOI URL for all articles (usually on front page of electronic version). The aim is to enable reader to follow up on your source. If possible, ensure DOI URL is to a publicly accessible site and article is freely available (not for sale). If no DOI, an OCLC Number/Unique Identifier is acceptable.

Non-English titles	Only provide the title and its translation if relevant in your text.	Reference it as any other book in English but add the official or personal translation of the title in square parentheses /brackets after the original title. Write the original title following title conventions in the original language (for example, in some other languages, titles are written in sentence case). Eberlein, U. (ed.) Chapter in Edited Book	Cite author you are quoting, as per normal book above. Note page numbers preceded by ‘:’ in text, and by ‘,’ in Ref list. Note Book title, followed by editor(s) in text. Fortin (1998) argues..... Reese clearly introduces these ideas (2002: ix-xxxiv).	Author, A. (year) ‘Chapter title: Subtitle’. in Book Title. ed. by Editor, A.
